DESCRIPTION / SPECIFICATIONS

This tender comprises the following aspects of works:

- Supply all necessary manpower, tools and transport to carry out Street Lighting Maintenance Works;
- Execute repair of all defective/faulty parts installed in the street lightings as necessary.

The specifications for this tender cover the whole existing distribution system in and around areas in Serian:

- i. From Mile 24 Kuching Serian Road to Serian Bazaar including all T-offs;
- ii. From Ensengei up to Kpg. Melayu D and all T-offs, Kpg. Bintawa up to Kpg. Seruit and all T-offs;
- iii. From Serian Bazaar up to Balai Ringin and all T-offs;
- iv. From Mentung 33/11 kV substation up to Sk Nyelitak including Pasir Putih Livestock, Sk Sg. Pinang and all T-offs;
- v. From Gedong Midpoint up to Kpg Gumpey, Gedong Bazaar and all Toffs;
- vi. From Slabi Junction up to Kpg Sengei 3 and all T-offs;
- vii. From Taman Kakai up to Tebakang bazaar and all T-offs. Tebakang Bazaar up to Tebedu, Entikong Border Post and to Kpg Gahat Mawang, including Kpg Tepoiand all T-offs;
- viii. From Tebakang Bazaar to Mongkos area, Muara Ahi up to Kpg Mentu Tapu, Kpg Daha Mawang and all T-offs.

This tender shall also include projects completed and commissioned during the contract period.

A minimum of **ONE (1)** competent person in **Low Voltage (Overhead Lines) up to 1kV**, holding SEB Competency and Authorization Certificates (CAC) are required for this contract.
